Appendix A to NOR+R

Current COVID Protocol information regarding entry to and exit from Mexico. Provided by Linda Oyler resulting from her frequent travels to both Cancun and Cozumel to visit her daughter Julie and granddaughters.

I was in Cancun and Cozumel from April 8 - April 19. Flying into Cancun there were no issues what so ever. Immigration & customs seemed sincerely happy to see visitors. Masks are still required on all flights and in all airports and the ferries. In both locations you must wear a mask inside any establishment. They take your temp and squirt hand sanitizer in your hand every time you enter a building. Most all businesses, including restaurants and bars are open at full capacity. No problem taking your mask off as soon as you sit down. A lot of locals wear masks outside. You will see signs encouraging this but no outside mask police. The US is still requiring proof of a negative Covid test within 72 hours of returning regardless of vaccination status. These tests are easy to come by. Most hotels offer them free for guests. There are test sites set up in several places and most farmacias do the test for about \$40 USD. Once you show your negative test you can get your ticket & boarding pass and you are never asked for it again. Arrival in the US is just as it has always been. As always, I was perfectly comfortable and happy to be in Mexico. Of course I talk to Julie in Cozumel every day. She says there has not been a change in any of the protocols since I was there.
